Presidents Message

President reflects on past year and looks towards the future

As I prepare to pass the gavel on to your incoming President, Jerry Shelton, I realize how quickly this last year has gone by. It has been a year of great activity and of continuous change. Serving as an officer in an organization such as the Kentucky Society feels much more like participating in a relay team, than running solo. This was a year of implementation of proposals from previous years, as well as a year of initiation of additional changes.

This year saw the full implementation of the Leadership Council, with its evolution as an advisory body for the board and for the Society as a whole. As representatives of our broad membership, the Council considered a

Through the outstanding participation of the Council in addressing a variety of key issues, the Board was able to quickly gain an understanding of the potentially

diverse views of a cross section of its members on a wide array of topics critical to all of us in our professional lives.

The implementation of both sections and new professional associates brought certain new textures to the Society's organizational needs. Decisions regarding services, rights and communication alternatives were key to introducing these new areas. Other states have bogged down in their efforts with these types of changes, and our state should be complimented for its willingness and ability to make needed, progressive structural adjustments. Congress Passes New Tax Legislation

The Economic Growth and Tax Relief Reconciliation Act of 2001 has been passed and signed by the President. The most significant tax issues of this new legislation are Individual Tax Rate Reductions, Expansion of Family Credits, Education Incentives, changes in the Estate and Gift Tax area, and the Pension and IRA Provisions.
